## **Presentation of the European Law and Governance School at the Presidential Palace of the Italian Republic/Il Quirinale**



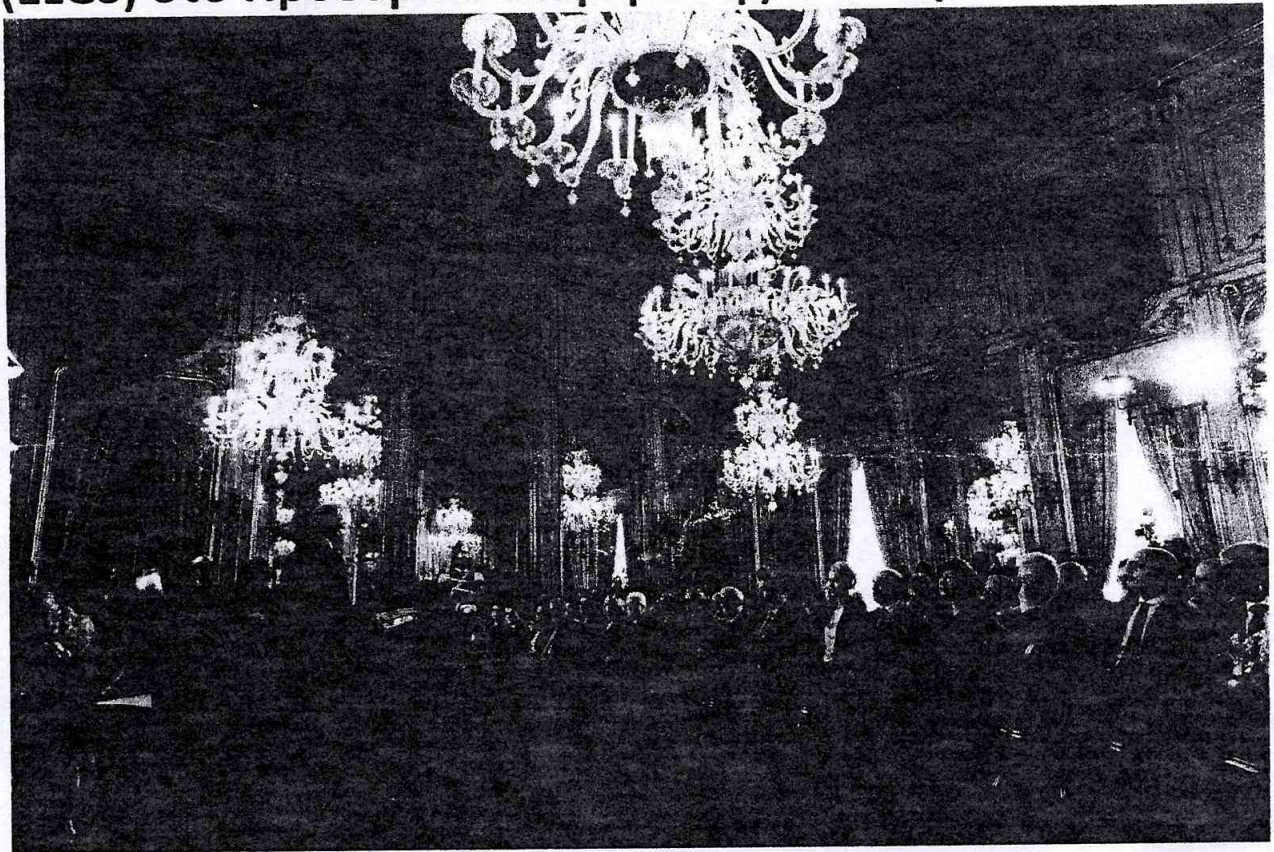

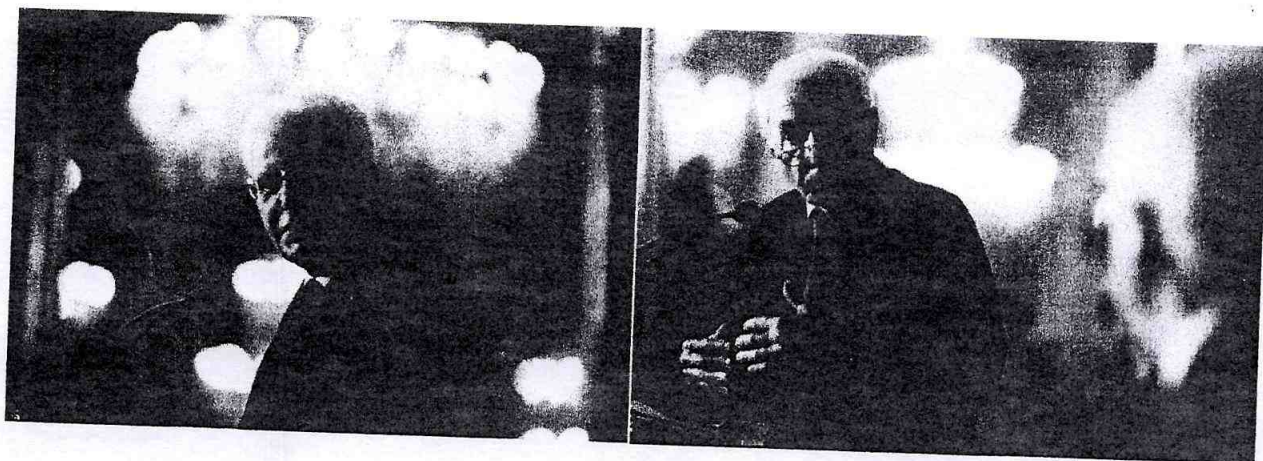

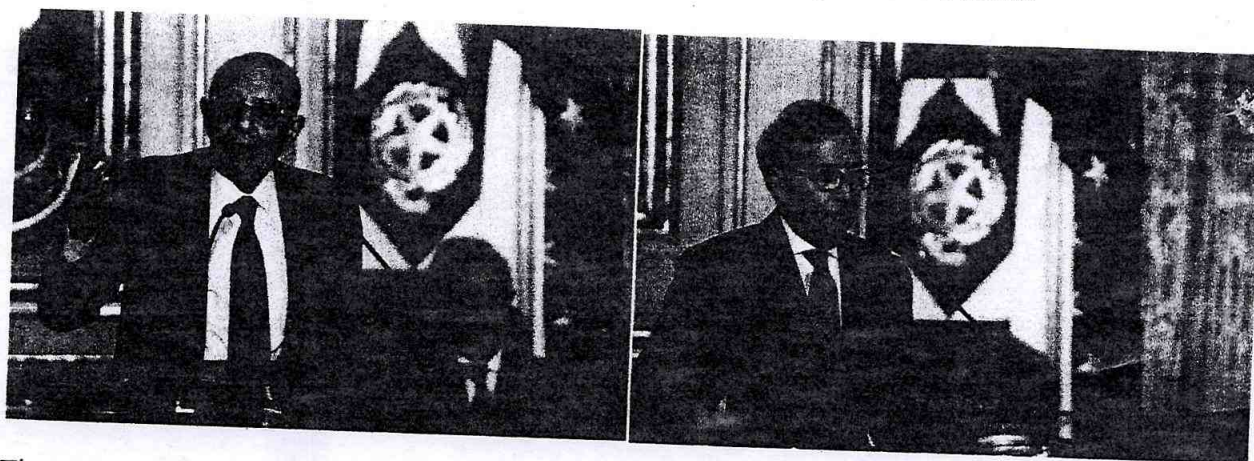
